League Rules

USTA AND GMITA INTERCLUB RULES APPLY TO ALL LCRAC LEAGUES

TO AVOID SCORING DISCREPENCIES

We have been using the unified scoring rules from Interclub League Play. It is used between all the clubs in the greater Milwaukee area and agreed upon by all involved managers or directors. It is used to simplify scoring and maximize your court time without taking away from the game.

RULES FOR ALL LEAGUES INCLUDING FIXED PARTNERS

Each match consists of 3 sets with one point awarded for each set won. The matches are 90 minutes in length, no ad scoring, with a 7-point tiebreaker at 6 all in each set. If a set is tied, the point is split. If a team is ahead by one game, the point is split. If the set has not been started no point is awarded. If a team is ahead by two games, that team wins the point. If a game is in progress at the time limit it must be played to completion.

WARM-UP

Consists of no more than 10 MINUTES, including serves, from scheduled start time.

NO-SHOW FEES

You will be billed a \$25 No-Show Fee to reimburse the scheduled players when the desk is notified. It is the attending player(s) responsibility to complete a no-show form and turn it into the front desk.

PLAYERS RESPONSIBILITIES

Be PUNCTUAL for league play, it is respectful for the other players. 10-15 minutes late will result in loss of warm-up.

After 15 minutes a \$25 No-Show Fee occurs to reimburse the other scheduled players and the court. It is the attending player(s) responsibility to complete a no-show form and turn it into the front desk.

NOTIFY FRONT DESK WHEN NO SHOWS OCCUR

Desk will enter No-Show Fees daily to reimburse scheduled players. It is the attending player(s) responsibility to complete a no-show form and turn it into the front desk.

FIND A SUB AND NOTIFY FRONT DESK SUB INFORMATION

No-Show Fees will be immediately billed to the missing person on record to reimburse the affected players. To avoid this bill when using a sub let the desk know who is subbing and the changes will be made. It is the attending player(s) responsibility to complete a no-show form and turn it into the front desk. The desk also needs this information to inform your sub of cancellations or occurrences.

CALL FRONT DESK TO OPEN UP ANY UNUSED COURTS

No-Show Fees can occur when scheduled courts are unused and left open. All balls, court time, schedules, drink tickets for winners (large soda, small juice or a tap beer), and 1st and 2nd place prizes for league winners are included.

- Courts will be reserved and all matches must be played at the scheduled time.
- Singles - you may cancel and reschedule with your opponent if you can't make it. Please remember to

cancel your court or you will be charged.

- **Doubles** - please try to find a sub, if a sub is not available please contact all three members scheduled to play in the match to cancel. Also, call the club to cancel the court. If you find a sub, be sure to contact the club with the name of the sub for the court sheet.
- **Score Cards**-Scorecards will be used to keep the integrity of the league at the level of play. Please return the scorecard to the front desk after the match.
- **Scoring**: Scoring is mandatory for all leagues. The scorecard will be provided prior to your match.

IMPORTANT REMINDER

- **Doubles**: No-ad scoring will be used. Doubles partners **WILL NOT** rotate after every set. Scheduled rotations are designed so you play as a team with each player at least once during the course of a season.
